# The University response is...

---

- A response – what is happening, how do we deal with it
- And *origin* – much of what we call Open Access comes out of the university environment

# OA-Early (kind of)

---

- Free publications
- Early OA journals – e.g. International Electronic Journal for Leadership in Learning (IEJLL) - 1997
- Faculty making articles freely available

# Universities tend to...

---

- Support Open Access
- Promote Open Access
- Create Open Access content

# More Recent Developments

---

- Open Access repositories – institutional and subject
- OA publishing
- OA Mandates – responding to mandates and creating mandates
- OA support programs for individuals
- Research into OA

# Open Access Repositories (OARs)

---

- One of the more well-known elements of the OA movement
- Institutional and subject repositories
- Some numbers: world=1320, Canada=48, BC=5 (or 6)
- >20 different types of repository software; most common are DSpace and Eprints
- Repository content is findable

# Institutional Repositories (IRs)

---

- Designed to house the scholarly digital output of their institutions
- Content doesn't have to be OA but most is
- Can be tools for the “green” arm of Open Access
- >30 university-based institutional repositories, according to CARL
- Still in early days

# Subject Repositories

---

- Similar to institutional repositories but focus on a discipline or subject area(s)
- Often originate in and/or are located at universities and collect publications by university faculty:
  - ArXiv (Physics – Cornell)
  - RePEc (Research Papers in Economics)
  - PubMed (health sciences)
  - DLIST (library and information science – University of Arizona)
  - E-LIS (library and information science - Italian Consorzio Interuniversitario Lombardo per Elaborazione Automatica (CILEA))



# Open Access Publishing

---

- Also a well-known element of the OA movement
- The “gold” road
- University presses
- Supports for OA publishing

# University Presses

---

- Some fairly heavy involvement in OA
- All two university presses in Alberta (University of Calgary Press, Athabasca University Press) have OA journals
- Athabasca University Press is all OA
- Are investigating Open Access for other formats

# Supports for Open Access Publishing

---

- Public Knowledge Project (PKP) including Open Journal Systems (OJS)
- The Synergies project

# Open Access Mandates

---

- Authors are required to make the results of their research openly accessible
- University response: responding to mandates and creating mandates
- >80 worldwide with more every few days

# Responding to Mandates

---

- Mandates are an increasing part of the OA world and universities have to deal with them
- This means more content for institutional repositories but more work, more pressure
- Faculty often need assistance and interpretation of grants, publisher agreements, etc.
- There is going to be more of this in the future

# Creating Mandates

---

- Universities, faculties, departments are increasingly requiring themselves to make their content openly accessible
- Some institutional mandates are well-known: Harvard (Faculty of Arts and Sciences, Law School, Kennedy School of Government), MIT, Oregon State University

# Open Access Support Programs For Individuals

---

- There are many programs, both from universities and organizations (e.g. SPARC, CARL), some informational, some fiscal
- Fiscal support: University of Calgary's Open Access Authors Fund, University of California's agreement with Springer

# Research into Open Access

---

- Research is a big part of what goes on at universities and researchers are working on OA
- Synergies has a specific research component



# Some Concluding Thoughts

---

- We live in interesting times – there is much going on
- New OA projects, programs, developments, etc. are emerging all the time
- It's getting hard to keep track and count of everything – a good sign!
- Keep your ears to the ground!
